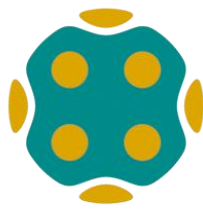

- Maintain close relations with the client and be frequently informed about the latter
- Never having been convicted of theft, fraud, mischief, forgery and use of forgery
- Reside in Cameroon, be cooperative and reachable

COMMITMENT:

As a Witness, you are solely responsible for making yourself available to FractAlls in the event of the relevant customer's unavailability and failure to meet any of their payment deadlines. You will find and share useful and up-to-date information related to this client in order for us to reach it and/or to find it to enter into possession of our due.

If you accept this commitment, in the event of your refusal to cooperate with FractAlls when the conditions require it, FractAlls reserves the right to sue you for - complicity and obstruction to recover the amount claimed from the client of which you are a Witness, - and claim against you for this due as compensation.

You can at any time contact FractAlls and ask to no longer be a Witness of the client concerned. Your request will be automatically approved if the customer has no more purchases in progress of payment. Otherwise, the client must first provide another witness in lieu.

PRECISION:

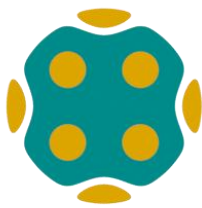
